



连接操作


配对方法:

恢复出厂设置

耳机开机在未连接状态下,同时长按音量"+/-键"5秒; 红白灯同时闪烁3次,耳机自动关机,恢复完成。






How to Connect

Power off headphones, press and hold on/off button for 4s or until LED blinks red and white to turn headphones connectable. On phone, search QCY C1 and tap to connect(LED stops blinking).



Factory Reset

Power on headphones and turn off phone's Bluetooth. Then press and hold both volume + and - for 5s or until LED blinks red and white 3 times to reset them to factory. They will auto power off after the factory reset.



How to Wear



- 1. Please put on headphones properly then adjust to fit vourself.
- 2.It will cause a bad calling or listening experience to wear them in a wrong way.

LED for Charging

LED will glow solid red when headphones are being charged and turn solid white when they are topped up.

Functions

- Power-on: Press and hold on /off button for 1.5s
- Power-off: Press and hold on /off button for 4s
- Answer/end call: Press on /off button
- Ignore call: Press and hold on /off button for 1.5s
- Skip track backward:
 Press and hold volume for 1.5s
- Skip track forward: Press and hold volume + for 1.5s
- (1+) Volume up: Press volume +
- (1-) Volume down: Press volume -
- Playback/pause: Press on /off button
- Voice assistant: Triple press on /off button
- O Low-latency mode: Double press on /
